65.17 Apologies for Absence. Apologies received from Cllr C. Bere, Cllr M. Saich and West Sussex County Cllr J. Dennis.

66.17 Declaration of interest by Councillors on any item on the agenda. None declared.

54.17 To approve the minutes of the previous meeting held on 11th July 2017. Minutes were agreed by Council and signed by Chair as a true record.

55.17 To discuss Highways issues. Clerk has now submitted a TRO request for plans previously circulated to both parishioners and councillors. This request will be discussed during November and Clerk will keep Council updated. Clerk will contact PROW to ensure footpaths are cleared and will copy this to Poynings Clerk.

56.17 Update by Mid Sussex District Councillor A Watts Williams. MSDC hope to adopt the District Plan early in 2018. Housing numbers have been revised by the Inspector and now stand at 876 per year through to the year 2023/24 subject to review these figures will rise to 1090 per year in 2024/25. Cllr Wilson and Clerk will attend a MSDC Planning update on 10th November 2017 to understand the impact these figures will have on surrounding areas. Cllr A. Watts-Williams left at this point to attend another meeting.
